

**WAIVER**

IN CONSIDERATION of being given the opportunity to participate in any Team Saquish Rowing Education Society, Inc activities (i.e. rowing, racing, practices, launching boats, loading boats, unloading boats, etc.) ("Activity") until the end of this calendar year, I, for myself, my personal representatives, assigns, heirs, and next of kin:

1) I ACKNOWLEDGE, agree and represent that I understand the nature of Rowing Activities, both on water and land based, and that I am qualified, in good health, and in proper physical condition to participate in such Activity and have completed the Medical Information Form.

2) I FULLY UNDERSTAND that (a) ROWING ACTIVITIES INVOLVE RISKS AND DANGERS of serious bodily injury, including permanent disability, paralysis and death ("Risks"); (b) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or the negligence of the Release's names below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable to me at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILIITY FOR LOSSES, COSTS AND DAMAGES I incur as a result of my participation in the Activity.

3) I AGREE AND WARRANT that I will examine and inspect each Activity in which I take part as a member of Team Saquish Rowing Education Society, Inc and that, if I observe any condition which I consider to be unacceptably hazardous or dangerous, I will notify the proper authority in charge of the Activity and will refuse to take part in the Activity under the condition has been corrected to my satisfaction.

4) I HEREBY RELEASE, discharge, and covenant not to sue Team Saquish Rowing Education Society, Inc, their administrators, directors, agents, officers, and volunteers, other participating regatta organizers, any sponsors, advertisers, and if applicable, owners and lessors of premises and, or equipment and vessels on which the Activity takes place (each considered one of the Release's herein) from all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Release's or otherwise, including negligent rescue operations; and I further agree that if, despite this Release and Waiver of liability, assumption of risk, and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the Release's, I WILL INDEMNIFY SAVE AND HOLD HARMLESS each of the Release's, from any litigation's expenses, attorney fees, loss, liability, damage or cost which any may incur as a result of such claim.

I have read this Agreement, fully understand its terms and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this Agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
